MASONIC HOME ADMINISTRATOR'S REPORT – APRIL

- We would like to thank the 25th Masonic District for being here to celebrate Easter with the residents again this year. The candy, gifts, and fun activities are very much appreciated.
- We would also like to thank the Grand Chapter of the Order of the Eastern Star for helping promote the care and services offered by the Masonic Home at the Annual Grand Chapter Session.
- First Lady Joy Hudson's Masonic Home Project is officially in operation. The newly remodeled wellness center is open and providing improved delivery of care. We want to thank all those who made this project a tremendous success.

LONG RANGE PLANNING COMMITTEE REPORT - APRIL

- 1. The Chiller Deck Roof repair is 99% complete at this point and the only thing left to do is the reinstallation of the vent piping that was removed for this project. This should be completed within the next 2 weeks.
- 2. All Florida Fire Equipment started the permitting process for the new kitchen Ansell System. We have a tentative installation date for the system of May 17th. This installation will continue through the evening of May 17th to minimize any inconvenience to the kitchen operation schedule.
- 3. The cooling tower restoration and replacement of the new fill medium was completed on March 31st. This installation took about 1½ days to complete in order to get the cooling tower back in operation.
- 4. Upcoming maintenance contracts for renewal in May are Safety Systems for the fire alarm and TAW for the generator service.
- 5. Update on the Guest House Project: All final inspections for the project should be completed by the end of next week.

MASONIC HOME BUDGET REPORT – MARCH

I am pleased to report that we have completed the Guest House Project so we are currently 1.0% over budget (\$83,933) for the fiscal year. If we adjust to the total budgeted for the Guest House Project, we would be 0.74% under budget (\$59,494).

REPORT OF THE GENERAL COUNSEL

I. CONTRACT REVIEW/GRAND LODGE:

Nothing was presented to General Counsel for review this past month.

II. PROPERTIES:

General Counsel continues to work with the land surveyor on the property in Starke to seek the abandonment of a road by the County and the fencing of the remaining property.

General Counsel continues to work on a Quiet Title action for the Carpenter Property in Lehigh Acres.

General Counsel continues to work on resolving issues relative to the Scally Trust Property, which now includes removing an automatic stay issued by the bankruptcy court after successfully obtaining a writ of possess for the subject property.

General Counsel has forwarded a deed and correspondence to the life tenant of the Castiglia Property located in Jacksonville, Florida, for direction from the Corporate Board and will be following up before the end of the month.

III. ESTATES:

General Counsel continues to monitor various open estates whose beneficiaries include Grand Lodge and/or the Masonic Home of Florida. Most recently, we have received a deed from the personal representative of the Estate of Edward Klein and the State Chairman of the Properties Committee, R : W : W. Wallace T. Fine, has already listed the property.

IV. MASONIC HOME:

General Counsel has revised the application checklist in the hope of avoiding further issues relating to applicants having transferred assets to a trust prior to submitting their application. General Counsel has spoken with our Administrator, Lisa Tsotsos, as to revising the application for Life Care to include questions relating to trusts and assets transferred to trusts and will be revising the same and drafting accompanying correspondence to the State of Florida requesting approval of the changes.

General Counsel has conducted a background and asset search for Robert Isgan, Dennis Metzler, and Clinton Mitchell.
